2. **Peer Reviewers:** Email the coach once peer reviewers are in agreement. A peer reviewer deletes this line after coach has been emailed to conduct the coach review.
3. **Coach:** <COACH name, and email> The coach deletes this line when the coach review is complete (and, if needed, suggested changes to feedback have been discussed with the peer reviewers and completed). Coach then contacts peer reviewers to complete the feedback input form (link below.)
4. **Peer Reviewers:** Enter info below into the Feedback Input Form (link). The peer reviewer who enters the information deletes this line. (Must be logged into MyPCC to open the form.)
