### Recommendation:

This new recommendation proposes edits to [G-33-3 Student Rights and Responsibilities](#), section H.iii.a, to better align with G-22-0 and drop the reference to an outdated conference system.

1. Change section H.iii.a title from "Acceptable Use of College Computer Services" to "Acceptable Use of Information Technology Resources" consistent with governing policy G-22-0.
2. Change reference from "the College Student Rights and Responsibilities Code of Conduct" to "G-22-0 Acceptable Use of Information Technology Resources." This eliminates the recursive reference to Student Rights and Responsibilities (this policy) and links to the governing policy G-22-0. NB: Include hyperlink <https://www.cocc.edu/policies/general-policy-manual/general/acceptable-use-of-information-technology-resources.aspx>.
3. Drop entire third paragraph. Policy G-22-0 addresses commercial use. COCC/NSFNET Backbone Services is no longer used as the COCC conferencing system. Zoom account registration addresses terms and conditions.
