I believe the proposed restructuring of the committee based on the recommendations of the Committee Review Work Group will benefit Student Affairs and may require more membership. However, if meetings were scheduled so that all members could show up, that may not be necessary.

#### a. Summary of Accomplishments & Opportunities:

Presentations were made to the committee on the Native Lands Acknowledgment, recipients of short term certificates to be acknowledged at commencement, moving advising and registration dates to earlier start times, Broadside update, potential for "coffee" meetings with College and Academic Affairs, Veterans Priority Registration, and recommendations from the Committee Review Work Group. All were supported favorably by the committee except the additional meetings with the College and Academic affairs. It was thought there could be other avenues of communication with those committees and that most of us were too busy.

The main action item we accomplished was selecting the recipient of the 2019-2020 Distinguished Student Award.

I believe the restructuring of Student Affairs with the added responsibilities based on the recommendations from the Committee Review Work Group (CRWG) will benefit the Student Affairs Committee and add more clarity to the purpose of the group. #### d. Considerations for next academic year:

- . CRWG has recommended for Student Affairs Committee's (SAC) restructuring with the following committees:
  - a. To eliminate ASCOCC Advisory Committee and its responsibilities to be adopted by SAC
    - i. This committee reviews grievances against student government and has only met 1 time after formation several years ago
  - b. To eliminate ASCOCC Appointment Committee and its responsibilities to be adopted by SAC
    - i. This committee hires, interviews, and selects members for student government
  - c. To eliminate Student Fee Committee and its responsibilities to be adopted by SAC
    - i. This committee creates the projection of student activity fees, allocates to clubs, sports, and Broadside based on requests, and provides recommendations to Alicia on distribution.
  - d. To eliminate Concerns and SAC to provide guidance for student concerns
    - i. This committee meets with a student when a student has exhausted all their resources and means; this ad hoc group comes together under extreme circumstances.
    - ii. Employee-related concerns should be recommended for HR/supervisors.
